COVID-Related Online Resources

vaers.hhs.gov (Vaccine Adverse Event Reporting System/VAERS): The site where you can report a mild to severe vaccine adverse event/reaction, vaccine injury, or a vaccine-related death. This is the official site of the U.S. Department of Health and Human Services (HHS).

VaxxTracker.com: After filing a report on the U.S. government's vaers.hhs.gov website (if needed), you can file another report on this site, which is an outside source vs. government. VaxxTracker.com was created by a group of NGO citizens concerned about potential risks associated with vaccinations. The VaxxTracker website acts independently from all government, pharmaceutical, or lobbying groups.
